- 10 Monthly payments of \$10000.00 ACH/ Credit Card or Check
(Monthly payments are one month in advance, (i.e. school year begins in August, the first payment is due July)

It is the parents (guardians) responsibility to insure payments are made on time. I (we) agree and understand that enrollment in Risen Christ Lutheran High School is limited to a set number of children, therefore, I (We) understand that if payments are not made within five (5) days of the due date, I (We) forfeit our Child's right to continue their education at Risen Christ Lutheran School, Therefore, if circumstances arise where payment will be delayed, please contact the School's Administrative Office and they will set up a meeting or telephone conversation with a representative of the Finance Committee to determine whether a solution for payment can be resolved.

I (We) also understand that should we decide to withdraw our child from the school after enrollment or after the school year begins, with the exception of a move out of the area of more than 40 miles. I (We) will be financially responsible for the entire year's tuition. If or when the School is able to fill the space, the tuition paid in advance (pro-rated, if appropriate) will be refunded minus a withdrawal fee of one (1) months tuition.

We understand the finances associated with operating Risen Christ Lutheran High School are paid for by Tuition, Fund Raising and Church member and also non-member contributions. It is understood that all families are required to participate in some of the selected family fund raising activities.
